



## SHORT ANNOUNCEMENT

*Selective procedure, for qualifications and interview, aimed at filling 1 post of fixed-term tenure-track researcher, reserved pursuant to art. 24, paragraph 1 bis of Law 240 of 30/12/2010 and pursuant to art. 14, paragraph 6 septiesdecies, of Decree-Law no. 36 of 30/04/2022, with a six-year, non-renewable contract, at the Department of Mathematics and Computer Science - S.S.D. MATH-04/A - Mathematical Physics*

Please refer to Annex 1 for specifications and details of the aforementioned position.

### **Application deadline:**

The application must be completed not later than 12.00 Noon on the thirtieth day following the publication of the Italian version of the Call on the official university bulletin board.

### **Admissions requirements:**

Only subjects in possession of a doctoral degree or equivalent obtained, in Italy or abroad, or, for the fields concerned, a medical specialization degree, are eligible to participate.

These procedures are reserved for subjects who possess both the following additional requirements:

- 1) who, for at least thirty-six months, even cumulatively, have attended PhD courses or carried out research activities on the basis of formal assignment, excluding activities for free, at universities or research institutes, Italian or foreign, other than the University of Palermo.
- 2) who are, or have been, for a duration of not less than one year, holders of fixed-term researcher contracts, referred to in Article 24, paragraph 3, letter a), of Law No. 240 of December 30, 2010, in the text in force prior to the date of entry into force of the law converting Decree-Law No. 36 of April 30, 2022 (L. June 29, 2022, No. 79)

OR

- 2) who have been, for a total duration of not less than three years, holders of one or more research grants referred to in Article 22 of Law No. 240 of December 30, 2010, in the text in force prior to the date of entry into force of the law converting Decree-Law No. 36 of April 30, 2022 (L. June 29, 2022, No. 79).

In the case of a doctorate obtained abroad, it is necessary to attach the decree of academic recognition of the qualification (so-called equivalence decree, issued pursuant to art. 74 of Presidential Decree no. 382/1980), for those who already possess it, or the provision for recognition of the qualification for the purposes of participation in competitions for researchers in universities and public research bodies, pursuant to and for the purposes of Legislative Decree 206/2007 - amended with Legislative Decree 15/2016 (for qualifications EU) - and of the Presidential Decree 394/99, art. 49 (for non-EU securities). Pending the release of the recognition provision by the relevant bodies, it is possible to produce the receipt of delivery of the request for the same.

The documentation proving the recognition of the foreign qualification must in any case be produced to the Administration before taking up employment.

### **How to apply**

Applicants must submit their application form, under penalty of exclusion, online, using the online application form available on the following webpage: <https://pica.cineca.it/unipa/>

The candidate will be able to access the competition platform using the SPID system (Public Digital Identity System), selecting the University of Palermo among the institutions or the candidate will be able to register and access using credentials issued directly by the platform

or authenticate with his/her LOGINMIUR, REPRISE or REFEREES account, if in possession. The computer application will require the possession of an e-mail address in order to register to the system.

Applicants must enter all the data required to produce the application form and attach the documents in PDF format.

The application form must be completed in all its parts, as indicated in the online procedure.

Other methods of sending application forms or documentation useful for participation in the procedure are not allowed.

The computer application allows applicants to save the documentation entered in draft mode, within the deadline for submitting the application.

The date of the electronic submission of the application is certified by the information system by means of a receipt, which will be automatically sent by e-mail when the application is submitted.

Once the application has been completed and all the attachments have been enclosed, the candidates must click on the "submit" button ("presenta"). The completion of the application will be proven only by the change in the status of the application, which will appear "submitted" ("presentata") and no longer "in draft" ("in bozza").

Upon expiry of the deadline for submission, the system will no longer allow access and sending of the online form.

Each application will be assigned an identification number which, along with the competition code indicated in the computer application, must be specified for any subsequent communication.

The procedure for completing and sending the application electronically must be completed no later than 12.00 AM on the thirtieth day following the publication of this notice on the official university bulletin board.

In case of access through identification through the SPID system, the application for admission to the selective procedure will be automatically acquired by the system without the need for a signature.

In other cases, under penalty of exclusion, the application form must be signed, must contain all the required data and be accompanied by a valid identification document.

The application can be signed with a PADES/CADES certified digital signature. Otherwise, candidates must save the PDF file generated by the system on their computer and, without modifying it in any way, print it and add a complete handwritten signature on the last page of the printout. This complete document must be scanned and uploaded to the computer system in PDF format.

**Candidates need to attach the following:**

- a) their scientific-professional curriculum vitae including a list of publications and qualifications;
- b) a copy of a valid identity document;
- c) the scientific publications submitted for assessment, already published by the deadline of this public notice, numbered in an attached dated and signed list (the number of publications must not exceed the number foreseen in the annex referred to in art. 1 of this notice), along with a statement about the sending and deposit of what foreseen in art. 5 of the Italian version of the call regarding publications;
- d) scientific publications submitted for evaluation;
- e) PhD thesis
