Public notice for the expressions of interest of scientists for the recruitment by direct call pursuant to art. 1, paragraph 9, law 230/2005 of associate professors or tenure track assistant professors

Art. 1

The board of directors of the University of Palermo in date July 25th, 2024 approved this advice for looking candidates with an exceptional international scientific academic record in order to recruit associate professors or tenure track assistant professors, by direct call pursuant to art. 1, paragraph 9, law 230/2005, in view of the activation of the master degree in Veterinary Medicine - LM-42. In the following the required scientific profiles:

Associate professor - SSD MVET-02/A (old SSD VET/03) Associate professor - SSD MVET-03/A (old SSD VET/05) Tenure track assistant professor - MVET-02/B (old SSD VET/04) Tenure track assistant professor - MVET-03/B (old SSD VET/06) Tenure track assistant professor - MVET-04/A (old SSD VET/07)

Art. 2

The following professional profiles are eligible:

- a) scientists who have been working on a permanent teaching or research position in a foreign university or research institution for at least three years, and holding an academic position equivalent to that is applying for based on the tables defined by the MUR
- b) Scientists who have been awared in the framework of specific research programmes of high qualification, financed by the European Union or the Ministry of Universities and Research and identified by the latter with a specific decree

Art. 3

Applicants must submit their application form online, using the online application form available on the following webpage:

https://pica.cineca.it/unipa/

The candidate will be able to access the competition platform using the SPID system (Public Digital Identity System), selecting the University of Palermo among the institutions or the candidate will be able to register and access using credentials issued directly by the platform or authenticate with his/her LOGINMIUR, REPRISE or REFEREES account, if in possession. The computer application will require the possession of an e-mail address in order to register to the system. Applicants must enter all the data required to produce the application form and attach the documents in PDF format

- motivation letter;
- curriculum vitae including a list of publications and a brief description of the most significant publications;
- statement of research, teaching, public engagement and so on (max 10000 characters included spaces);
- documents proving the correspondence between the Italian and foreign academic positions.

Once the application has been completed and all the attachments have been enclosed, the candidate must click on the "submit" button ("presenta"). The completion of the

application will be proven only by the change in the status of the application, which will appear "submitted" ("presentata") and no longer "in draft" ("in bozza").

This notice is valid until 30/11/2024.

Art. 4

The committee, named by Rector in accordance with art. 2 of the Regulations for direct calls of fixed-term professors and researchers - R.D. no. 4269 of 05/10/2022, will make evaluation of the submitted documents in adherence to the aforementioned regulation. Experts in the specific scientific-disciplinary group (formerly concurring sector) or scientific-disciplinary sector can provide their contribution to the evaluation.

Art. 5

The direct call procedure is governed by national legislation and by the provisions of the Regulations for direct calls of fixed-term professors and researchers - R.D. no. 4269 of 05/10/2022.

The submission of expression of interest does not guarantee entitlement for participating in procedures for accessing the qualification of teaching personnel of the University of Palermo.

Art. 6

In case that one or more procedures are concluded with the authorisation by the MUR for direct call, the recruitment of professors and/or tenure track assistant professors will be done only if the activities of the LM-42 degree course will initiate.

Art. 7
