Dr. Curtis F.J. Doebbler is Research Professor of Law in the Department of Law at the University of Makeni, Sierra Leone; sole proprietor of The Law Office of Dr Curtis FJ Doebbler; and a founding member, first President, and the Main Representative to the United Nations Headquarters for International-Lawyers.Org.

He holds a Juris Doctors (J.D.) degree from New York Law School in New York City in the United States; a Meester in de Rechten (mr. or LL.M. degree) from Radboud Universiteit (formerly Katholieke Universiteit Nijmegen) in Nijmegen in the Netherlands; and a Doctor of Philosophy (Ph.D.) from the London School of Economics and Political Science in London the United Kingdom. His Ph.D. was on the individual under international law and supervised by Professor Dame Rosalyn Higgins and Professors Peter Muchlinski and Gunter Tüebner.
