













# Summer School 2024 Democracy and Climate Justice

The PhD courses in "Human Rights: Evolution, Protection, and Limits", "Legal Pluralisms: Ancient and Current Perspectives", "Gender Studies", and "Ecological Transition", in collaboration with the Center for Sustainability and Ecological Transition, the master's program in "Law and Techniques of Ecological Transition", and the Erasmus+ Project "Climate Justice Living Lab" of the University of Palermo, are organizing the *Summer School* entitled: *Democracy and Climate Justice* (hereinafter referred to as: *Summer School*).

#### ART. 1 – GENERAL INDICATIONS

# I-PREMISE

The relationship between democracy and climate justice plays a crucial role in the contemporary time, characterized by growing awareness of the global challenges linked to climate change. Democracy, as a fundamental principle of modern political systems, constitutes the fertile ground upon which decisions and actions to mitigate environmental impacts and promote sustainability are based. However, the full realization of these goals requires a deep integration of democracy with climate justice, a concept that focuses on the equitable distribution of the burdens and benefits of climate actions.

Firstly, democracy provides an institutional framework where political participation and accountability are crucial for effectively addressing environmental issues. Fair access to information, transparency in decision-making processes, and the opportunity for citizens to express their opinions are essential elements for formulating inclusive and forward-thinking climate policies. In this context, democracy not only allows for a more faithful representation of the diverse voices and interests of society but also fosters the creation of policies that respond to the needs and concerns of all segments of the population.

However, democracy alone is not sufficient to ensure climate justice. Climate justice requires an integrated approach that considers not only environmental but also social and economic aspects. This implies recognizing existing inequalities in the capacity for climate adaptation and mitigation, as well as acknowledging the differentiated responsibilities between developed and developing countries in causing and addressing climate change.

Furthermore, climate justice demands a long-term vision that protects the rights of future generations and communities most vulnerable to climate impacts. Democracy, when adequately integrated with the principles of climate justice, can act as a catalyst for the adoption of policies and actions that promote environmental sustainability, social equity, and inclusion. Ultimately, the synergy between democracy and climate justice represents a moral and political imperative in addressing the challenge of climate change and building a















resilient and sustainable future for all.

Interdisciplinarity will be the fundamental pillar of the Summer School. Through this approach, a pathway will be outlined based on the constant reference to human rights, allowing for the exploration of the mutual interaction between climate change and rights protection. The latter will not only be considered as negative constraints on public policies but as a fundamentally important element in the development process. The Summer School, therefore, aims to create an environment where it is possible to analyze the link between climate change and human rights, in order to promote solutions that effectively integrate both dimensions, thus contributing to a path of sustainable and rights-oriented development.

#### II - OBJECTIVES AND TOPICS

The Summer School, which will lasts six days, serves as an opportunity for in-depth exploration and debate on four topics of crucial importance in the current global context: the science of climate change, ecological transition, the sources of climate rights, and trends in climate jurisprudence. At a time when environmental issues are increasingly urgent, this initiative aims to provide a comprehensive exploration of the multifaceted aspects of climate change and strategies to address it.

The interdisciplinary approach adopted during the Summer School will allow for the analysis of the climate change issue from various perspectives, integrating scientific, political, legal, and social knowledge. Through seminars conducted by experts, participants will have the opportunity to gain a broader and deeper understanding of the factors contributing to climate change and possible solutions to effectively address it. Moreover, during the final two days of the Summer School, special space will be reserved to facilitate active participant engagement. Indeed, PhD students will have the opportunity to present their ideas and research through a dedicated call for abstracts on the theme of democracy and climate justice. This will enable them to share their perspectives and actively contribute to the academic debate on this crucial topic. Furthermore, also during the final two days, the Summer School will offer the opportunity for direct engagement with environmental associations and non-governmental organizations active in the field of environmental protection and human rights. These meetings will be a valuable opportunity to establish constructive dialogue between young researchers, academic experts and activists, to share knowledge, experiences, and best practices, and to develop common strategies to address environmental challenges and promote concrete actions for a more sustainable and just society.

### **III - METHODOLOGY**

As indicated in the attached program, each day will consist of two sessions discussing multiple specific topics from various theoretical and practical perspectives, aiming to achieve effective integration of methods and solutions. Speakers will suggest pre-reading materials to prepare participants for the topics under discussion, facilitating a deeper understanding and more fruitful discussion of the issues at hand. At the end of each seminar, there will be space for a debate involving all participants.

To ensure maximum participant engagement, the *Summer School* proceedings will include a *Workshop* titled "*Democracy and Climate Justice: an interdisciplinary approach*," where works proposed and developed by the participants who answered the call for papers will be presented.

#### IV - WORKING LANGUAGES

The activities of the Summer School will be conducted in English.

# ART. 2 – ADMISSION CONDITIONS

- 1. As established by Article 4 of the Regulations for the Activation of International Courses of Advanced Studies "Summer and Winter School" of the University of Palermo, the following are eligible to participate in the Summer School:
  - a) Students enrolled in a doctoral course at an Italian or foreign university.
  - b) Students who have already obtained a Master's or Doctorate degree in Italy or an equivalent degree abroad.
  - c) Students who have obtained a bachelor's degree in Italy according to the regulations prior to D.M. no. 509/99 or an equivalent degree abroad.
  - d) Students who have obtained a three-year or specialist degree in Italy or abroad according to D.M. no. 509/99 or an equivalent degree abroad.
  - e) Students who have obtained a three-year or master's degree in Italy or abroad according to D.M. no. 207/2004 or an equivalent degree abroad.
  - f) Researchers from an Italian or foreign university.
  - g) Students enrolled in a three-year, specialist, or single-cycle master's degree course at an Italian university who have acquired at least 120 CFUs (university credits) overall.
- 2. The minimum number of participants required to activate the Summer School is 15 (fifteen) candidates.
- 3. Not more than 80 (eighty) applications will be accepted, with the following clarifications:
  - At least 5 (five) spots are reserved for participants selected by the University of Tarragona, a partner of the Erasmus+ project "Climate Justice Living Lab".
  - At least 5 (five) spots are reserved for participants selected by the University of Mariupol, a partner of the Erasmus+ project "Climate Justice Living Lab".
  - The maximum number of participants described in paragraph 1 of this article, letter g), cannot exceed 10 (ten) students.
  - At least 50 percent of the spots are reserved for participants who have obtained the admission qualification from other university locations, either in Italy or abroad.
  - At least 15 (fifteen) participants will be selected among candidates from universities other than the proposing university.
- 4. Where necessary to conduct a selection (in the event that applications exceed the number of 80), the















Scientific Committee will compile a list of accepted participants and a waiting list. Candidates on the waiting list will be contacted in case any of the accepted participants withdraw.

Selection will be based on Curriculum vitae, declared qualifications, and attached motivational letter.

#### **ART. 3 – APPLICATIONS**

- 1. To register for the *Summer School* it is necessary to fill in and transmit the *application form* attached to this *call*, in compliance with the procedures described in the following paragraphs.
- **2.** Candidates must attach to the *application form* (Attachment 2):

  - motivational letter (max 250 characters).

# ART. 4 – SCHOLARSHIP COVERING REGISTRATION EXPENSES FOR THE SUMMER SCHOOL

- 1. All students who are not enrolled in the doctoral courses identified in paragraph 4 of Article 3 can benefit from a scholarship covering the total registration fees for the *Summer School*.

The maximum number of proposals admitted will be 15.

Each PhD student will have 10 minutes to present their paper, followed by a brief discussion.

Presenters may use a slideshow in ".ppt" format (Microsoft Office PowerPoint).

The selected and presented abstracts will be published in a dedicated section of the Living Lab platform of the Erasmus+ Project "Climate Justice Living Lab". The papers, which will be submitted in their final version by a deadline that will be announced at the conclusion of the *Workshop*, will be collected, and published in a volume funded by the Erasmus+ Project "Climate Justice Living Lab".

A contribution is provided to cover the total expenses incurred by PhD students for registration to the *Summer School*, which is a prerequisite for participating in the *Workshop*.
