### The Contribution of Item Response Theory to the Problem of Scaling Psychological Variables

The contribution of Item Response Theory (IRT) to the issue of scaling psychological variables lies in its ability to provide a sophisticated framework for measuring latent traits. IRT enhances the precision and validity of psychological assessments by modeling the relationship between individuals' responses to test items and their underlying psychological traits. Unlike traditional

scaling methods, IRT accounts for varying levels of item difficulty and discrimination, offering a more nuanced and accurate representation of psychological constructs. This approach improves the reliability of measurements and facilitates the development of more effective and individualized assessment tools.

[ 02/2022 – 09/2022 ] **Center of Gravity as Index Of Prejudice**

This study aims to assess ethnic prejudice using an index obtained by recording spontaneous body movements in response to ethnic stimuli. This new index has been correlated with traditional self-report measures of prejudice and with the implicit prejudice index obtained through the IAT. Thirty participants (23 women, 7 men) observed the faces of Black and White individuals while standing on a baropodometric platform used to record body displacement around the center of gravity. The same participants completed the Subtle and Manifest Prejudice Scale (Pettigrew & Meertens, 1995) and underwent a race IAT test (Greenwald et al., 1998).

The results show that displacement of the body around the center of gravity in response to a series of Black faces is correlated with implicit measures of ethnic prejudice: greater racial bias is associated with a greater backward shift of participants' center of gravity when viewing Black faces.
